# **TERMS & CONDITIONS**

These Terms and Conditions are between TheNewClimate and every person who confirms attendance (speakers, guests, & attendees), verbally or in writing/email registration, else every person who completes the relevant registration via website, ("You") for the Climate Salon as described in the website www.climate.salon ("Event").

### Confirmation of registration

1.All attendee registrations are subject to availability and acceptance by TheNewClimate, which will be confirmed in writing (including by e-mail) after TheNewClimate has received the completed registration form, the related fee if required (the "Fee"), and anything else that TheNewClimate may require.

All speaker and guest registrations are subject to availability and acceptance by TheNewClimate, which will be confirmed in writing (including by e-mail).

2.Upon TheNewClimate's written confirmation to You of its acceptance of your registration for a place at the Event there shall be a legally binding contract between TheNewClimate and You to which these terms and conditions apply.

3. The NewClimate reserves the right to refuse to accept any registration in its absolute discretion.

Fees

4.Fees for the Event are correct at the time of publication. TheNewClimate reserves the right to change the Fees at any time but changes will not affect registrations which have already been confirmed by TheNewClimate. You acknowledge that TheNewClimate cannot guarantee places held on a provisional basis and that places may sell out.

5.The Fees include:(i)For guests: one place at the Event(ii)Event materials or food & beverage, if any.

6. The Fees do not include travel to or from the Event or any accommodation costs incurred.

7.Complimentary Registrations: All Event guests attending with complimentary registrations agree to these Terms & Conditions. Those who receive a complimentary registration understand that the cost of their registration is being paid for by another party. Thus, if the guest does not come to the Event, the guest agrees to a no-show fee of \$500 USD to be paid in full by December 20th, 2025, through a Stripe payment link, provided by TheNewClimate.

### Changes, Cancellations and Postponements

8.Whilst our agenda is correct leading up to the event, in certain circumstances it may be necessary for TheNewClimate to alter the content, format, venue or timing of an Event.

9.If You cannot attend an Event for which You have registered, please contact TheNewClimate as soon as possible (and in any event no later than 48 hours before the Event). TheNewClimate may at our absolute discretion allow You to send a substitute in your place (provided that TheNewClimate has received the details of such substitute) or allow You to attend the next available Event.

10. There are no refunds for tickets purchased.

11.TheNewClimate may in exceptional circumstances need to postpone or cancel an Event, and we will notify You as soon as reasonably practicable of any such cancellation or postponement. You agree that TheNewClimate's liability to You will be limited to the amount of the Fees You have paid and TheNewClimate will not be liable to You for any expenditure, damage or loss incurred by You as a result of the cancellation or postponement.

### Your attendance at the Event

12.Please advise us of any special access requirements at the time of making your registration.

13.TheNewClimate reserves the right, without any liability, to refuse You admission or eject You from the Event for failure to comply with these Terms; or if in TheNewClimate's opinion You represent a security risk, nuisance or annoyance to the running of the Event.

14. You are permitted to make reasonable photographs at the Event, in each case for your own personal use. You must not make video or audio recordings of the whole (or substantially the whole) of the Event or of any session within the Event, or use any recordings or photographs for commercial purposes, unless expressly permitted by TheNewClimate. You acknowledge that attendees will treat event content (attendees, quotes, etc) as off the record and not for attribution, as per Chatham House Rules.

15. You acknowledge that the Event or part of it may be filmed by audio, visual, audio-visual or electronic means or photographed, including photographs of individuals or groups of guests. You agree to permit TheNewClimate, or any third party licensed by TheNewClimate, to use and distribute such footage and photographs, which may feature images of You, in all or any media (including social media) whether now known or hereafter to be invented throughout the world in perpetuity for the purposes of advertising, publicity, reporting and otherwise in relation to the exploitation of such recordings and photographs.

16. You are responsible for arranging your own appropriate insurance cover in connection with your attendance at the Event. To the maximum extent permitted by law, TheNewClimate shall not be liable for any kind of loss or damage to You or your personal property, unless caused by our negligence.

17. Materials distributed by or on behalf of TheNewClimate at an Event may not be reproduced without TheNewClimate's permission.

### TheNewClimate Liability

18. Views expressed by speakers are their own and TheNewClimate disclaims all liability for advice given or views expressed during an Event. Materials distributed at an Event are intended for information only and should not be relied upon.

19. To the maximum extent permitted by law, TheNewClimate shall not be liable to You for any direct, indirect, economic or consequential loss or any loss of business, use, profit, anticipated profit, contracts, revenues, goodwill or anticipated savings arising in connection with this Agreement, even if You have been advised of the possibility of such loss or damage.

### Your details

20. By submitting registration details, You agree to allow TheNewClimate to contact you as required for the organization and administration of the Event. TheNewClimate will comply with our privacy policy in respect of your registration details and other information we hold about you.

21. The names, job titles, organizations, and LinkedIn URLs of all registered guests may be placed on the guest list for the Event. This list may be provided to sponsoring companies and to all guests via an online attendee directory or via email, so that they can see who is at the Event for the purpose of networking and meetings. Guests acknowledge and agree that they shall not, under any circumstances, use the guest list for their own promotional and marketing purposes.
